THE STAFF AND VOLUNTEERS WORK TO RECOVER FOOD TO AVOID IT GOING TO WASTE AND TRANSFORM IT INTO HOT, TASTY, AND NUTRITIOUS MEALS FOR PEOPLE IN NEED THROUGHOUT THE REGION. THEY DITRIBUTE IT THROUGHOUT SOUTHERN CALIFORNIA THROUGH THEIR OWN VEHICLES AS WELL AS A NETWORK OF NONPROFIT PARTNERS. IN DOING SO THEY ALSO OFFER TO SUPPLY SUPPLEMENTAL FOOD ITEMS AS WELL AS CLOTHING, DIAPERS AND OTHER HOUSEHOLD ITEMS WHEN MADE AVAILABLE TO THEM.
